As a full ISA member, your school is inspected by the Independent Schools Inspectorate (ISI) for your full age range. Please note that the current ISI charges are £2255 per year, plus a per capita charge of £6.25pp where the number on roll is more than 150 pupils. Please remember that as a new member to ISA, you are required to attend our Heads Induction Conference, preferably in your first year of membership and certainly by the end of your second year.
